# President's Annual Report

This is my first report to the Club as President. It has been an exciting and challenging year but one where I feel a lot has been achieved. Firstly, this is the first year that all clubs have had the opportunity to exercise their democratic right to vote and it has been interesting to note how many clubs exercised that right. The office publicised extensively the fact voting papers were being sent out to clubs, that there was a new system for electing your President and members of Executive Council, but still the response from member organisations was low.



In terms of candidates, the North Island was well contested but the South Island drew only four candidates for four seats. However having said that we do have two new councillors representing the South Island so no doubt that will bring some new ideas, new thinking and new talent onto the Executive Council. The changes to our constitution were intended to make the process of selection of our representatives more accessible to the broader membership and while we may not quite be there yet, the arrival of a number of new faces point to the fact we are headed in the right direction. There is still work to be done to get the model right but that is something the incoming Council may wish to direct their attention to.

It has also been pleasing to note the interest the media has shown in the New Zealand Kennel Club (NZKC) and its activities and views during the past 12 months with the press regularly seeking the opinion of both Peter Dunne and myself on various matters during the year on matters related to dogs, dog ownership and dog-related issues. In the past these enquiries have been limited to calls about dogs biting people and have been in circumstances where most commentators have been wary to comment. It does reflect a growing appreciation of the organisation and its influence. Particularly pleasing was an interview with one lobby group who praised the Kennel Club for its work on canine health issues. An important signal of how the NZKC has managed to reposition itself in the eyes of many, a good sign for the future.

## Financial

The financial position of the NZKC is strong. We need to acknowledge the good work, skills and talent of our senior management team and the generosity of our sponsors.

Total income increased from last year by \$56,593 (3.1%) and despite operating expenses increasing by \$146,593 (9.44%) we still achieved a net surplus after depreciation of \$41,551, which was only \$6,475 below budget.

## Sponsorship

The NZKC enjoys a generous arrangement with Eukanuba and Peter and I are presently in discussions with our sponsor about the future of that arrangement. We hope to be in a position to report on that shortly. NZKC is fortunate to attract such a high calibre sponsor and it is thanks to Eukanuba that the NZKC has been able to maintain the level of service to its members and its financial strength without a substantial fee increase. Their support for our premier events has also allowed us to showcase our activities to broader audiences in both New Zealand and around the globe. I place on record our appreciation for the excellent support we receive from Eukanuba our principal sponsor.

## Major Events

### National Dog Show

In 2014 we held the Eukanuba National Dog Show in Auckland and achieved unprecedented levels of media coverage for our sport. Over 3500 members of the public attended the event, TV1, TV3, MāoriTV, MoreFM, the Breeze and local print media including the NZ Herald ran features on the National Dog Show. This was backed up by 42 supporting fixtures at the Auckland Exhibition Events Centre. DogNews Australia and *k9online* magazine also ran features. The level of exposure was unparalleled in both dog and public media channels which served well to promote our sport and the cause of pedigree and purebred dogs to the general public. The Auckland event ran at a small loss subject to resolving some outstanding issues around a grant received from the Sovereign First Trust.

### NDOA & NZDAC

Both events ran successfully. I attended the NDOA held in Feilding with Gerry and Dave and had a thoroughly memorable weekend while Beth and Brian attend NZDAC held in Invercargill.

### The Animal Welfare Amendment Bill

At the time of writing we are still awaiting the passing of the Animal Welfare Bill into law which is due at any time. The NZKC has spent significant time making representations on the various provisions of the Bill to Ministry of Primary Industry officials and representatives of the National Animal Welfare Advisory Committee. As advised to members previously, we believe the legislation will empower the Minister to regulate in a number of key areas including the areas of surgical procedures, breeding strategies, the care and welfare of animals, the transportation and constraint of animals, and the tether of animals, and animals in entertainment—the details of which are still not clear. As Owen advised in 2014 the Kennel Club uses a government relations specialist in these to assist in these

representations and has used the same company for nearly 15 years so they know our business, issues and environment well. Our account manager with the company is a former agility competitor and is a highly skilled communications strategist.

### **Local Government**

During the year we have submitted on dog control policy to several councils including Auckland Council, Waikato District Council, South Taranaki District Council, Invercargill City Council and Southland District Council and we will have a stand at the Local Government Conference in July this year. This is part of our endeavours to grow awareness and visibility of NZKC in local government circles. The messages in these circles have been very clear about why dog breeders are important to their communities—they produce dogs that perform essential services from support to the police through to the blind and others who are physically impaired. The Kennel Club also offers a range of training services including its Canine Good Citizen programme to help support good behaviour in canines and responsible dog ownership mainly through our obedience clubs. Other support is also offered through breed clubs.

### **Canine Health and Welfare**

One of our key initiatives this year was the Canine Health and Welfare Roadshow with Karen Hedberg led by Pam Douglas and our Canine Health Subcommittee this gave the NZKC an opportunity to showcase the good work being done by our Canine Health sub-committee. Three workshops were run in Auckland, Horowhenua and Christchurch. We would have liked to run more but like all new initiatives when you kick things off you are never sure how much appetite there will be for these sessions. As it turned out they were very popular and the numbers who turned up to each session were very good. We could have run more sessions but Karen was only available for the week. In addition, our Breeders Ethics Subcommittee has completed their report on a Breeders Code of Ethics which has been reviewed and approved by Executive Council. This will be introduced next year following receipt of submissions from members. There were some minor amendments to the NZ draft Code that appeared in the *Dog World* earlier this year to reflect the feedback received. The most significant recommendation came from the Canine Health Subcommittee and that was for the Code to be mandatory.

### **New Zealand Veterinary Association (NZVA)**

The New Zealand Kennel Club has made real progress in its relationship with the NZVA. This is the national industry organisation for veterinarians and while not every veterinarian belongs to it, most do and those that are members of our Canine Health and Welfare committee are members. It is

the body responsible for industry development and carries considerable influence in political circles and with tertiary institutions and clearly is important in the development and training of future veterinarians. For this reason NZKC has considered it important to build a strong long-term relationship with NZVA. As I reported in *Dog World*, NZVA has invited our Canine Health Committee to contribute regular features to their magazine *Vetscript* and also have negotiated an opportunity for experienced breeders to speak to graduating students at Massey University about the expectations of a dog breeder of their veterinarian. I think these are important opportunities to build bridges between breeders and our future veterinarians.

## Strategic Plan

This year the NZKC has been working on a plan to position the NZKC under the new banner of Dogs New Zealand. This proposed change of name to Dogs New Zealand better describes our business, so when customers search for dog related matters, it is more likely they will be directed to the NZKC. With this will come a focus on member education and advocacy around best practice for dog owners and breeders, a stronger voice for member clubs and a focus on promoting the benefits of owning a pedigree dog. This will be the positive future of the NZKC. One of the first initiatives off the ground will be a series of fact sheets communicating to members what the NZKC does for you. We have completed the strategy as a draft document and this will be rolled out for feedback from members. Work has commenced on both a business plan and communications plan to support the strategy once finalised.

## Junior Handler

I must mention Pascale Sperling who represented New Zealand so well at Crufts this year in the Junior Handler event. Pascale was at 13, the youngest competitor in the event and did an outstanding job in making it down to the last 10 finalists. Well done Pascale!

Finally to Gary Doyle and John Vuleta, both of whom have decided to retire from Executive Council after many years service to the New Zealand Kennel Club. You will both be missed. Gary it will not be the same without you. In the 10 years I have served on Executive Council the one constant has been Gary so it is with some sadness I say goodbye.

# Committee Reports

## Agility

Agility has continued to grow over the last year and agility members now represent approximately 21% of the membership of the NZKC. This continued growth, while very welcome, presents some challenges of its own with bigger shows, more stress on equipment, difficulties with finding enough trainers, etc.

The Agility Committee has responded to these challenges and opportunities. Our main focus in the past year has been on the safety of our equipment and to ensure that competition equipment is as safe as possible for our dogs. We have set up a system of Certificate of Fitness (COF) inspections. This means we have systematically inspected, or will inspect every Agility Club's, agility equipment to make sure it is up to the standards we have set.

The COF progress was designed to be run in a cooperative manner with our clubs rather than us laying down the law and we accordingly allowed a decent budget to help clubs improve their equipment. The COF process will be completed in June 2015.

We have also continued to give grants to clubs to allow them to bring in trainers from outside their own clubs or immediate area and to encourage clubs to do displays for the general public to help increase our membership and public awareness of our sport.

We set up a structure to allow a more regional focus, with each committee member taking responsibility for communication with a regional group of clubs. This has helped keep clubs in touch with the Agility Committee and given clearer lines of communication.

NZDAC 2014 was held in Gore and got great reviews from those attending. Due to its location entry numbers were relatively low and the event ran at a small loss. In contrast this year, NZDAC will be held in Tokoroa and is expected to receive record high entries and to run at a profit. A notable first in the recent past was that the first NZ Agility Judge was invited to judge in Europe. Alan Rohde was selected to go to Italy to judge at the IFCS World Agility Championships in April 2015. We are looking forward to his report and ideas after he returns.

In May 2015 a new Agility Committee takes over (I can't say was elected) as again we had a late withdrawal which meant that we only had enough nominations to fill the eight positions on the committee. Only 3 of the new committee are existing committee members so the new committee will have some fresh ideas. We are looking forward to an interesting and positive year ahead.

## Breed Standards

The Breed Standards Committee met four times during the year via teleconference and also conducted some matters via email. We reviewed a number of items referred to us by Executive Council and also submissions received from clubs and individuals.

One new breed, the Thai Ridgeback, was recognised and the FCI Standard for the breed was adopted. This has been placed into Group 4 and all Hound Group judges have been required to sit and pass an Open Book examination on the breed.

The Peruvian Hairless Dog had a new FCI Standard published which allowed for a coated variety, this Standard was adopted for all three sizes of the breed.

The committee was asked to consider whether the colour 'Champagne' should be a recognised colour for registration in Poodles, this was not accepted.

We recommended an amendment to the acceptable colours for the Miniature Schnauzer to bring us into line with ANKC and FCI.

Research was undertaken into all Breed Standards regarding dew claws. A report was prepared for Executive Council outlining the requirements of every standard where dew claws are mentioned.

The committee recommended the adoption of statements at the beginning and end of each Breed Standard relating to the health and welfare of each breeds. As a result Judges must now take health and welfare into account when making their assessment of a dog as obvious issues are now regarded as a fault.

The committee also agreed to changes to NZKC Procedure 25 "Alterations to Breed Standards" which can now be actioned at any time during the year and in relation to the adoption of new breeds and Standards accepted in Australia.

A number of typographical errors were corrected in several Standards.

The new Kennel Club (UK) Standard was adopted for the Bouvier des Flandres.

The current Standard of the Affenpinscher was considered following a comprehensive submission from a group of breeders and owners. This engendered considerable debate amongst the committee and we reported back on a number of options available to Executive Council.

Finally I take this opportunity to thank the members of this committee, Annette Buxton, Bernard Fears, Rosemary Weaver, Brian Harris, Karen McIntyre, Pam Douglas and Sue Chaytor, for their work and contribution during the year.

## Canine Health

The objective of the NZKC Canine Health Committee still continues to be to investigate health issues affecting the various breeds NZKC members are involved with and to encourage sound breeding practices including the reduction/elimination of significant inherited disease without reducing the genetic variability available to breeders in New Zealand.



The committee will once again review submissions from breed clubs and after reviewing submissions received will publish a list of additions and alterations of testing requirements for some of the breeds. Canine health issues worldwide and the testing regimes are rapidly changing with new DNA tests becoming available.

Representatives of the Canine Health Committee and NZKC were invited to Ministry of Primary Industries (MPI) to sit before the committee who were tasked to write the technical paper on 'Hereditary Breeding Problems in Pedigree Dogs' for the Minister.

The highlight of this year has been the week of open meetings held in Auckland, Christchurch and Wellington (Levin) with Dr Karen Hedberg. Dr Hedberg is Chair of ANKC Canine Health and is very willing to work closely with us. We once again went to MPI where Dr Hedberg and Dr Wylie participated in a teleconference on concerns with breeding problems in purebred dogs. We would like to thank the Executive Council for funding this week of meetings.

We still need to have collated accurate information and feedback regarding the incidence of inherited disease for our different breeds. At present there is only the limited information we have received from accredited breeders as to the incidence of disease within breeds. We would encourage breed clubs to collate data for their breeds, which include results of verified health tests. There has been information collected from veterinary surgeries where the difference between Pedigree Registered dogs is not distinguished from purebred and possible cross breed dogs. This information could be used to seek controls put on pedigree dog breeding in the future. We are not scare mongering but are very aware of the possible future direction of Government policy.

My thanks go to my committee who all give of their time freely for the future of our sport.

These cost about \$750 each, and it is worth noting that NZKC Museum Trust is a registered charity (No CC47047).

The museum is going to be enlarged soon, with the wall to the next room being removed. This will give more room for display and storage, without reducing the security of the area. Heat pumps will assist in maintaining the optimal temperature and humidity to prevent degradation of the exhibits.

We have received, with thanks, quite a few items that have been donated throughout the year, and will gratefully accept further items to complement the range of memorabilia housed in the museum now. In addition, the *NZ Dog World/NZ Kennel Gazettes* have now all been bound, up to the end of 2014.

An aspect we are now working on is that of the oral history of NZKC. Our Club has a rich history and the museum is keen to record this from the member's viewpoints themselves. As a standalone historical artefact or as a provenance for some of the physical artefacts in the museum, the oral history will be of great benefit for future researchers.

With the National Dog Show being held at the NZKC Eukanuba Centre at Porirua this year, there will be plenty of work done to prepare the museum in time. It will be a good opportunity to showcase the past to the present.

# Obedience

## Strategy for Growth

Over the past year there has been a focus on determining the issues facing Obedience clubs both from a domestic training and a competitive perspective. Many clubs are finding it increasingly difficult to get enough trainers to run their domestic training (which is the main source of income for the obedience clubs) and participation is steadily declining in most areas including on club committees and at Obedience competitions. Meetings were held with Obedience clubs in each of the three regions to try to better understand the problems facing the clubs and how the New Zealand Kennel Club and the Dog Obedience Committee could help.

It is still early days but the meetings provided a valuable source of comments and ideas which will be used to come up with an action plan on how we can help grow the clubs and increase participation in competitive Obedience, Rally-O shows and Working Trials. Something that the NZKC office has started doing recently for obedience and other clubs is making an online show entry system available and this has been very well received by the clubs and show secretaries who have made use of this service. A key area that we need to focus on is providing help for clubs in training the trainers and this is a likely starting point.

## Committee Elections

The two-yearly elections for the Dog Obedience Committee Chairperson and the three regional representatives were held in April 2015. The current office holders were all re-elected unopposed:

Chairperson: Geoff Collins

Northern Region Representative: Sue Howe

Central Region Representative: Sue Richardson

Southern Region Representative: Arend van den Bos

## National Dog Obedience Assembly

In 2014 the NDOA was hosted by the Central Region at Manfeild Stadium in Feilding over Labour weekend. This was a very successful event and it was pleasing to see so many people having fun throughout the weekend both during the show and at the social events. It sometimes seems that people forget that competing with their dogs is supposed to be enjoyable so I was happy to see such a good atmosphere over the weekend.

The NDOA continues to be impacted by the closeness to the National Dog Show (which is now only three weeks before the NDOA) and the clash with the New Zealand Dog Agility Championship event. Ideally these three national NZKC events would be spaced more evenly throughout the year and this is something that we are keen to address. A survey was held in late 2014 with Obedience members to look at views on this and



other issues affecting the NDOA with a view to determine how we make the NDOA an even better event.

## Voting Registers

Another thing we have been working on this year is the development of a proper database to keep track of who is on the various voting registers. This is almost complete and should make future distributions of discussion and voting information easier for the committee and for the voters, and will hopefully result in higher voter participation.

## Rally-O

Rally-O is continuing to grow, especially in the Northern Region, although the rate of growth has slowed somewhat. There has been a slow increase in a number of judges, but more are needed, especially in the Central Region.

As a result of a regulation change last year the Rally-O subcommittee region representatives are now elected by a national nomination and election process. Nominations for the Northern and Southern representatives were called for in early 2015 and the following people were elected unopposed for a two-year term:

Northern: Ann Davis

Southern: Ruth Thorburn

Helen Carter continues in the Central Region Representative role which will be up for election in early 2016.

## Working Trials

Participation in Working Trials remains fairly steady thanks to the efforts of some dedicated people in each of the regions. However, this does tend to happen largely in the background, even at the larger events like the National or the NDOA, due mainly to the remoteness of the trials locations. This makes it harder to attract new people although the seminars that are held each year are an excellent introduction into the world of Working Trials.

The current Working Trials subcommittee consists of Rosemary Cleator and Meg Hansford (Central). Jenny Butler and Rena Shaw (Northern) and Jan Dean and Susan Sheppard (Southern).

Finally I would like to thank my fellow Dog Obedience Committee members and also Peter Dunne, our Director/Secretary, for their excellent work over the last year. I do spend quite a bit of my time in meetings and it is encouraging that the DOC meetings are proving to be not just worthwhile but actually enjoyable.

## Auckland Property Management

I am delighted to once again be in a position to report a strong cash positive performance for the Auckland property and another year where we have made significant progress on a range of property improvements and enhancements that will deliver long-term benefits to our property. During the year we have enjoyed strong support for our



two benefit shows which allowed us to deliver considerable profits (18K) into our operational account for some major upgrades. We were also the recipients of generous donations from Manukau Dog Training Club that enabled us to complete the purchase of the required number of extendable ring barriers (5K) and from The Collie Club (5K) that we have used to provide a large concrete unloading pad alongside the indoor venue. In addition to these one off contributions we continue to receive very solid 'gold coin' donations support which assists us in maintaining our ongoing operations.

### Financial Matters

Subject to final audit we anticipate a trading surplus before depreciation in excess of 38K for the financial year. I am thrilled to deliver this result which is our 3rd consecutive cash positive result, quite a contrast to the years of losses that members had to endure over the preceding four years. To deliver these results and to continue the upgrades we are delivering is a testament to the level of commitment and hard work of our property management committee. It is also very pleasing that we have several new members who have volunteered to join us this year. I am indebted to the full committee for their dedication and efforts and I sincerely thank you all for your contributions throughout the year.

### Property Upgrades During the Year

During this year we have embarked upon a number of significant new projects. Details of the major projects are detailed below.

**Water Tank Project** - We have now completed the water tank installation project. The property is now entirely managed from our own tank water supply where we collect rain water from the indoor venue roof. We were required to either upgrade our bore water supply or collect rain water, by June 2015, in order to comply with changing water purification requirements mandated by Auckland Council. The cost of this project, fully funded from our cash flow, was in excess of 38K which includes the



cost of fully fencing the three tanks and water pump area. We are working through the formal advice process to Auckland Council to ensure we no longer continue to pay for water from the bore. The property house has also been transferred over to the rain water system.

Replacement of Indoor Lights—During this year we have replaced all of the indoor lights with new LED daylight harvesting lights. These lights adjust to the amount of natural light and adjust their brightness upwards or downwards dependent upon the natural light available. The indoor venue now provides over double the light power delivered by the old lights that were beginning to progressively fail. Since their installation our energy savings have reduced our power consumption and cost by over 50%. The replacement of these lights cost in excess of 25K.

Toilet Block Drainage Repairs – Due to ongoing drain blockages, caused by tree root damage, we were facing regular and untimely failure of our toilet facilities. We have now removed the offending belt of trees, alongside the toilet block, that were the cause of the frequent failures. Since removal of these trees we have replaced the damaged section of drains and now envisage a period of trouble free operation. These activities accounted for a little under 10K of our maintenance costs this year.

Tree Planting of Whippet Racing Track – When we were given consent for parking over, Auckland Council required that we plant a shelter belt alongside the whippet racing track, with a requirement that these reach two metres in height before we can again use the triangle paddock for racing and off leash use. We have planted the full length of the track with “Pittosporum Karo” trees, over 300 trees, and these have now begun to establish themselves and we are seeing solid growth.

### **National Show Week – Auckland 2014**

During the National show week we hosted 36 conformation specialty shows, at Ardmore, with 3402 dogs exhibited over a four day period. The Prelude Show, held on the property, commenced the supported entry activities with a huge entry of 900 dogs. The full National week entries totalled a massive 6041 entries. Amazingly that is over a 1300 more dogs than the Spring Fair in Australia drew this year, some 1910 more than the 2014 Sydney Royal and a whopping 2599 more than Melbourne Royal. If you measure success by the numbers it certainly was a huge success. When you add to the mix the extraordinary level of positive exhibitor endorsements, the level of satisfaction we received from our concessions holders, the atmosphere at both of our venues, the wonderful spirit of cooperation we received from clubs, exhibitors and officials and the compliments we received from an enormous number about the conditions they witnessed at our Ardmore home, I think we can all be justly proud of the roles we have played in delivering on our commitments to provide a National Dog Show to remember.

Re-surfacing of an exit ramp has been attended to by Elaine Pearce, and the Dunedin City Council has completed a creek cleanout and drainage work around the building. Injury at conformation shows and in agility competitions to both handlers and dogs was becoming a very real possibility.

Our three August Championship Benefit Shows were again very successful with a nice level of entries for these difficult times. Again, the wonderful support from the Otago Canine Training Club, Otago Kennel Association and Southern Ladies Kennel Association, together with local businesses and the many local members who also give generous support with donations and time, is sincerely appreciated.

A new arrangement presently being developed with interested OCTC members, is the private use of the Centre by individuals for their personal dog obedience training during weekdays. We would like to thank Diana O'Kane for bringing this possibility to the attention of the committee, together with her probable administration of a scheme that should extend the productive use of the Centre, and benefit the obedience fraternity.

## Wellington Property Management

The Porirua property (Eukanuba Wellington Event Centre) has achieved an operating surplus for the year ending 31 March 2015 of \$37,225 which is \$14,625 up on budget. The corresponding surpluses in 2014 and 2013 were \$34,010 and \$20,596 respectively. Income was up from the previous



year by \$9,233 and expenditure up by \$6,018. \$6,000 of the improved profit was derived from the two extra Benefit Shows run by a group of members in conjunction with NZKC management. Their time and efforts are truly appreciated.

It is important that the venue continues to show surpluses given the age of the building. The roof in particular remains a concern and at some point in the near future will require significant investment. Whether this is by way of an interim measure or something much more significant will likely be a consideration for Executive Council sooner rather than later.

2015 sees the return of the Eukanuba National Dog Show to Porirua. The 2014 event was held in a commercial venue and this worked very well for our Auckland based organisers and NZKC. In 2016 another commercial venue will be utilised in Christchurch so it will be interesting to gain member's views on the 2015 event where our own venue is being utilised. In many respects it would not be fair to draw exact comparisons but the overall feel from the exhibitors, the public and other partners will possibly set the scene for future events, particularly in the Wellington region.

The annual meeting was held in April with the resident Wellington clubs with it again being a key communication tool for NZKC moving forward. It is an ideal opportunity to report on the year past and what is planned in the next. The 2014 meeting saw the group formed to stage the two benefit shows already reported on and these are being repeated in September, 2015. These two shows take the total being run in the venue to the maximum allowable of four with all proceeds going to specific projects. It is therefore once again relevant to note and thank Gary Carleton and the team from the Hutt Valley Kennel Centre for their on-going support of the venue in the staging of two benefit shows per annum. Gary has also taken on the task of managing the Prelude show leading into this year's National Dog Show, so once again, thank you Gary.

# Remits

## REMIT 1 by the Executive Council

### Rule 21 CONSTITUTION AND ELECTION OF OFFICERS – clause (d) (i) (4)

*Following a vote by the Agility membership in March/April 2015 the following change is proposed:*

#### Current

Rule 21(d) (i) Membership of the Executive Council shall be:

- (1) The President, ex officio, who shall be the Chairman of the Executive Council and
- (2) Four members residing in the North Island, and four members residing in the South Island as elected at the relevant Annual Conference.
- (3) The New Zealand Obedience Committee Chairperson. A deputy shall act as an alternative in the absence of the Obedience Chairperson.
- (4) The New Zealand Agility Committee shall appoint one member who will be the Chair of that Committee, and a deputy who shall act as an alternative in the absence of the Agility Chairperson.**

#### Proposed change

- (4) One member of the New Zealand Agility Committee. A deputy shall act as an alternative in the absence of the delegated committee member.**

#### Rationale

These changes are proposed as a way to better spread the workload of the Agility Committee. Both the Chairperson responsibilities and the Executive Council responsibilities are huge roles and currently one person is expected to cover both. The Agility Committee feels that the committee would function better if these roles were shared more evenly, and so encourages all delegates to vote for the changes.



## REMIT 2 by the Executive Council

### Rule 21 CONSTITUTION AND ELECTION OF OFFICERS – clause (a)

#### Proposal

Amend Rule 21 (a) by adding the following as shown in red

#### 21. CONSTITUTION

(a) Delegates assembled at the Annual Conference of Delegates (and who are entitled to vote as detailed in Rule 17 hereof) shall elect a Patron, and Vice-Presidents. Nominations for President and those members of the Executive Council elected under Rule 21 (d) (i) (2) hereof, shall be called for by the Director/Secretary at least three months before the annual conference and be made in writing to the New Zealand Kennel Club. Nominations may be made by any Affiliated, Associated or Recognised club or any financial member of the New Zealand Kennel Club. **Such nominations must be received by the Director Secretary by a date specified by the Executive Council.** Nominations must be accompanied by brief biographical notes. In the event that these nominations are insufficient to fill the required vacancies under subparagraph (d) (i) (1) and (2) hereof, those nominated shall be declared elected at the Annual Conference of Delegates following their nomination provided that they are delegates to that conference pursuant to Rule 16 or, in the case of an incumbent President, are eligible to serve a further term in that office. Any resultant vacancies shall be filled by nominations from the floor of the conference. Should nominations exceed the number of positions available, Rule 21 (b) shall apply.

All candidates are required to be a delegate when first elected to office provided always the retiring President, whether a delegate or not, shall be eligible for re-election

#### Rationale

When the rule was rewritten an inferred reference to a closing date was deleted. This remit will put in place a closing date that will comply with our rules and give consistency that was lacking. While there is a generalised closing date it is felt that a clear definitive date will give a high degree of certainty while at the same allowing a degree of flexibility if that should be needed.

## Proposal

For consistency with the changes made under Rule 21 (a) the term two months be replaced with the same wording as proposed under Rule 21 (a).

### 37. ALTERATION OF RULES

- (a) The Rules of the New Zealand Kennel Club may be altered, added to or rescinded by resolution passed by a majority of not less than two-thirds of those voting in respect thereof at any Annual Conference of Delegates provided that not less than three months previous notice shall be given of the meeting, and ~~two months~~ notice in writing of the proposed alteration, addition or rescission has been given to the Director/Secretary, who shall forward a copy of such notice to each affiliated society and body or individual entitled to appoint delegates to such annual conference (pursuant to Rule 16 hereof), twenty-eight clear days before the date of the meeting at which it is to be discussed. ~~Such proposed alteration, addition, rescission must be received by the Director Secretary by a date specified by the Executive Council.~~

## Rationale

This change not only gives consistency in wording between Rule 21 (a) and Rule 37 but also addresses timing issues related to the printing of the *Year Book* and its distribution to the membership within the required 28 clear day period.





# REMIT 3 by the Executive Council

## SECTION II MEMBERSHIP—Rule 7 ASSOCIATE MEMBERSHIP

### Proposal

To remove Associate Membership (Rule 7) as an option for NZKC Membership with the current associate members being notified and given the option of transferring to full membership (upon renewal of membership date).

The deletion of Rule 7 will require the renumbering of subsequent rules.

### Rationale

NZKC already has a unique and complicated structure in terms of its membership i.e. having dual club and individual components. The Associate Membership option has been available for seven years and has only 11 members i.e. about 0.17% of the total membership. The number of 11 associate members is a drop of three from 2014.

Members of the public also have the option of subscribing to the *NZ Dog World* i.e. without having to be a NZKC member.

### 7. ASSOCIATE MEMBERSHIP

(a) Any person interested in the wellbeing of dogs whether he is a member of the New Zealand Kennel Club pursuant to Rule 4 hereof or not may apply to the Director/Secretary for associate membership of the New Zealand Kennel Club.

**Any person interested in the wellbeing of dogs already has an alternative in that they may join a member club of NZKC**

(d) An associate member or members may, subject to the approval of the Executive Council, enrol any dog in the Companion Dog Directory whether it is otherwise registerable under Rule 32 or not and irrespective of whether the dog is purebred or not.

**The Companion Dog Directory has only eight dogs registered and it is also proposed that this be disestablished and any dogs on it be transferred to Part 2 of the Register. There have been no new registrations since 2011 and it can be assumed that of the eight dogs some will now be deceased.**

## REMIT 4 by Dog Obedience Committee

### REMIT 4 – SECTION III AFFILIATED, ASSOCIATED AND RECOGNISED SOCIETIES–Rule 10 (b) (c) (d) & (e). Originals (e) & (f) renumbered – by Dog Obedience Committee

#### Proposal

To have written into the NZKC Rules permission for Specialist Breed Clubs who conduct regular obedience classes to host All Breeds Championship Obedience Shows.

#### Rationale

For many years, in at least one Region, a Specialist Breed Club has been co-hosting an All Breeds Championship Obedience Test annually, albeit under the name of an All Breeds Obedience Society to remain within current NZKC Rules and Regulations as well as the NZKC Dog Obedience Regulations. What is proposed now is removing the necessity to hide behind another Obedience Society, in order to continue doing what a Specialist Breed Society has effectively been doing successfully for many years.

It is well understood why a Specialist Breed Club cannot host a Specialist Breed Championship Obedience Show, but there is no known logical reason why they cannot host an All Breeds Championship Obedience Show. As already stated, this has already been happening for many years.

Acceptance of this proposal only further legitimises what is already occurring. It would also allow for Specialist Breed clubs to establish greater financial outcomes, instead of having to split costs; create a potential for more Championship Obedience Tests to be conducted, and potentially encourage more Specialist Breed Clubs to become active in the promoting of Obedience within their own Breed.

The original rule includes the phrases Specialist Breed Clubs (including in the title of the rule) and Specialist Clubs. To avoid possible confusion instances of the words Specialist Clubs have been changed to Specialist Breed Clubs.

#### 10. ASSOCIATED SPECIALIST BREED CLUBS

- (a) A Specialist Breed Club is a society which caters for one breed only (or for one breed dog training only), provided always that for the purpose of Rule 9 and this Rule 10(a) but for no other purpose, Pembroke and Cardigan Welsh Corgis shall be deemed to be one breed, and provided further that in the case of a breed in respect of which a separate register is kept for any variety of such breed then there can be a specialist club catering for any one such variety.



- (b) Specialist **Breed** clubs as defined in Rule 10(a) hereof, may with the approval of the Executive Council become associated to the New Zealand Kennel Club.
- (c) Specialist **Breed** clubs may with the approval of the Executive Council conduct Open Shows.
- (d) Specialist **Breed** clubs (~~but not Specialist Breed Dog Training Clubs~~) may with the approval of the Executive Council conduct two Championship Shows per year.
- (e) **Specialist Breed Clubs** compliant with NZKC Dog Obedience Regulation 2.4.1.2 may with the approval of the Executive Council conduct two All Breed Championship Obedience Tests per year.
- (f) The provisions of Rule 8, subclauses (b), (c), (f) and (g) shall apply with necessary changes to all specialist **breed** clubs.
- (g) The Executive Council may disassociate a specialist **breed** club from the Kennel Club for good reason.

## REMIT 5 by the Executive Council

### SECTION VII DISCIPLINE AND SETTLEMENT OF DISPUTES

#### Proposal

To remove Section VII (Rule 35) from the NZKC Rules and establish it in its entirety as the 'Discipline and Settlement of Disputes Regulations'.

NZKC Rules (Sections & Rules) to be renumbered accordingly.  
Discipline and Settlement of Disputes Regulations to be renumbered accordingly.

All other relevant Rules and Regulations to be adjusted accordingly.

#### Rationale

A review of this area has been on the books for some time. At a previous ACOD a guest Speaker Mr Hobbs, a lawyer of considerable standing and experience, had addressed the ACOD at the invitation of the Executive Council. One of his recommendations was the removal of the relevant section from the rules and to undertake a simplification of the said section. A working group was established to undertake the task of simplifying this section but found that to do so would be extremely difficult. By making the section a regulation the Executive believes that a working party could achieve a better result by being able to gradually bring about the necessary changes without causing any disruption to its effectiveness or disadvantaging any member. The Executive acknowledges that there is a need to have in place strong and effective regulations as regards conduct, but that there is also a need to make them easily understood and manageable.



## REMIT 6 by Executive Council

### RULE 35.3 LAYING A COMPLAINT

#### Proposal

To allow a visiting, officiating judge to lay a formal complaint under Rule 35.3.

Amend the current rule 35.3 (a) to read, by adding the words in red.

#### 35.3 LAYING A COMPLAINT

(a) Any member, society **or visiting, officiating judge** may lay a complaint.

Amend the current rule 35.3 (f) to read, by adding the words in red.

(f) The complaint must be accompanied by the complaint fee, **except in the case of a visiting, officiating judge.**

Amend the following rule 35.4 (a) by adding the words in red.

#### 35.4 COMPLAINT LODGEMENT FEES

(a) **Except in the case of a visiting, officiating judge,** the following fees shall be payable to the New Zealand Kennel Club and shall accompany any matter lodged.

#### Rationale

Our current rules do not allow a visiting, officiating judge, who is not a member of the NZKC, to lay a formal complaint. The judge may feel that such a complaint is warranted as a result of an incident arising during their contracted period. These amendments would bring NZKC in line with overseas kennel controls.

## REMIT 7 by The Griffon Bruxellois Club (Inc)

### RULE 8 (c) ADDITION OF 'NZ' AFTER THE SOCIETY NAME

#### Proposal

To allow societies to place 'NZ' after their name

That Rule 8(c) be amended to read:

With the exception of the New Zealand Gundog Trial Association, the New Zealand Hunts Association and the New Zealand Dog Judges Association (Inc) the words 'New Zealand' shall not be used as part of the name of any affiliated, associated or recognised society, but '(NZ)' may be included after the name. The word 'club' shall not form part of the name of any affiliated society.

#### Rationale

In this digital age where so much communication is by electronic means it is important that clubs are able to differentiate themselves from others in the world which may have the same name. This is particularly applicable to breed clubs.



# RECOMMENDATIONS

## Recommendation 1 by Tauranga KA

### SHOW REGULATION 2.1.2.1 – NO APPROVAL FOR TWO (2) ALL BREED CHAMPIONSHIP SHOWS ON SAME WEEKEND

#### Proposal

Amend Show Regulation 2.1.2.1 by changing 'day' to 'weekend'

#### Rationale

Tauranga Kennel Assn had applied for our show weekend to adjust to Labour Weekend as we had found an adverse effect on numbers due to following directly after the National Dog Show week. Our committee/club are working hard to find a strong judging panel and attract Specialty Clubs to come on board and support each other to create an attractive weekend for our exhibitors. We now find a barrier with it being a three day weekend, and working to give our specialist clubs a day to themselves that another Club in the same Island has booked a Benefit Show on that day. We feel this will no doubt have an adverse effect for all clubs involved and now feel this is the only way to secure that our future entries won't be depleted. This will not affect All Breed Clubs that work together to run their four show weekends as all they need to do is provide written consent as already in the stated in the Show Regulations.

#### Current Regulation

2.1.2.1 – The New Zealand Kennel Club shall set a five year calendar for All Breeds Societies which shall be circulated to all Affiliated and Associated Clubs annually. Unless otherwise requested All Breed Clubs will be allocated the equivalent date in each successive year. Approval will not be granted for two All Breed Championship Shows on the same **day**, in the same Island (North Is. Or South Is.) unless the written consent of both clubs is approved.

#### Amend to

2.1.2.1 – The New Zealand Kennel Club shall set a five year calendar for All Breeds Societies which shall be circulated to all Affiliated and Associated Clubs annually. Unless otherwise requested All Breed Clubs will be allocated the equivalent date in each successive year. Approval will not be granted for two All Breed Championship Shows on the same **weekend**, in the same Island (North Is. or South Is.) unless the written consent of both clubs is approved.

## Recommendation 2 by Executive Council

### SHOW REGULATION 19—EXHIBITION OF DOGS

#### Proposal

To not allow bitches in season to be exhibited.

#### Rationale

Responsible dog ownership is an important part of NZKC's philosophy. The taking of in-season bitches to a show, and the exhibition of them falls short of this goal.

Bitches in season have the potential to create issues for male dogs in close proximity to others, and also can cause distraction issues for dogs within the ring.

This change will bring Conformation in line with the Dog Obedience and Agility sectors. It will also align NZKC with most local authorities, which do not allow in-season bitches in public places.

#### Add Regulation 19.11 Bitches in Season

Bitches in season are forbidden to compete at or attend any NZKC competitions or fixtures. Any person presenting a bitch in season at any NZKC competition or fixture and the bitch itself will be liable to suspension for a period of up to 12 months.

#### Renumber 19.11 (current) and onwards

Amend Regulation 19.14.1 (current) Withdraw Prior to Judging at Show.

Any dog may be withdrawn from a show and, provided a request for a refund is made at the time of withdrawal, entry fees paid shall be refunded. Written application must be made to the Secretary of the Club prior to the commencement of judging of the breed concerned.

From

- If in dog training disciplines the entry being a bitch entered in the show comes into season.

To

- If the entry being a bitch entered in the show comes into season.



## Recommendation 3 by Versatile Hunting Dog Test Assn

### HEALTH TEST RESULTS ON PEDIGREES

#### Proposal

That health test results on official results form as supplied by a Veterinarian/University etc. forwarded to NZKC by the breeder or NZKC registered owner of a dog be shown on said dogs NZKC pedigree, and that all mandatory health test results as shown on Accredited Breeders scheme list that are submitted remain on NZKC pedigrees for three generations.

Each breed has its own important health issues so a suggestion may be that either the dog owner selects three to have shown on the pedigree or there is a given number of spaces to use (much like the dogs registered name) and the dog owner has to work around this.

#### Rationale

Genetic health issues are an important part of sound breeding choices, and the publishing of health test results that are retained on pedigrees can only assist in the advancement of elimination of health issues within a breed.

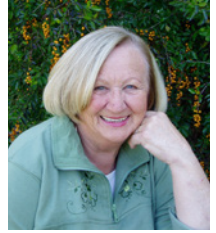

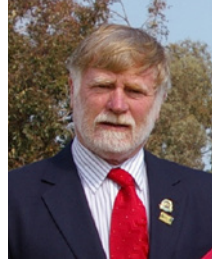

# Discussion Paper

## Registration Regulations

By Geraldine County KA

### **9.1 – COMPULSORY REGISTRATION OF ALL PUPPIES**

In reference to “Did you know?” published in the *Dog World* November 2014 issue.

Re: Compulsory registration of all puppies.

If not all puppies are registered simultaneously there is a problem with the remaining unregistered puppies. After two years there may be many unregistered puppies. This situation will be difficult to rectify.

In reference to “Did you know?” published in the October 2014 issue of *NZ Dog World* October 2014.

Re: Registration on the Restricted Register.

The NZKC office advises any registration applications received without the new owners written agreement will be rejected.

### **Rationale**

There is difficulty obtaining compliance in this situation. The regulation 9.1.1 does not state this requirement therefore it cannot be mandatory.

## INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF THE NEW ZEALAND KENNEL CLUB INCORPORATED

### Report on the Financial Statements

We have audited the financial statements of the New Zealand Kennel Club (the "Club") on pages 4 to 13, which comprise the statement of financial position as at 31 March 2015, and the statement of financial performance and the statement of movements in equity for the year then ended, and a summary of significant accounting policies and other explanatory information.

This report is made solely to the Members, as a body, in accordance with Rule 23(a) of the Rules of the Club. Our audit has been undertaken so that we might state to the Members those matters we are required to state to them in an auditor's report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the Members, as a body, for our audit work, for this report, or for the opinions we have formed.

### Executive Council's Responsibility for the Financial Statements

The Executive Council is responsible for the preparation and fair presentation of financial statements in accordance with generally accepted accounting practice in New Zealand, and for such internal control as the Executive Council determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

### Auditor's Responsibilities

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with International Standards on Auditing and International Standards on Auditing (New Zealand). Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. Other than in our capacity as auditor, we have no relationship with or interests in the Club.

**1. STATEMENT OF ACCOUNTING POLICIES**

**Reporting Entity**

The New Zealand Kennel Club Incorporated (the "Club") is a society incorporated under the Incorporated Societies Act 1908. These financial statements are for the group which comprises the Club, the New Zealand Kennel Gazette Limited registered under the Companies Act 1993, a wholly owned subsidiary of the Club and the New Zealand Kennel Club Museum Trust Incorporated (the "Museum Trust"), which the Club has control over.

**General Accounting Policies**

These financial statements are a General Purpose Financial Report as defined in the Statement of Concepts of the Chartered Accountants Australia and New Zealand and have been prepared in accordance with New Zealand generally accepted accounting practice ("NZ GAAP").

**Measurement Base**

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on a historic basis are followed by the society.

**Specific Accounting Policies**

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied:

**(a) Goods and Services Tax ("GST")**

These financial statements have been prepared on a GST exclusive basis, except for accounts receivable and accounts payable, which are reported on a GST inclusive basis.

**(b) Property, Plant and Equipment**

Property, plant and equipment is recorded at historical cost, less depreciation to date.

**(c) Depreciation**

Depreciation has been calculated on a straight line basis at the following rates:

Buildings	2.50%
Freehold Improvements	10.00%
Computer Equipment and Software	25.00%
Tractor and Equipment	15.00%
Office Furniture, Equipment and Tools	10.00% to 20.00%

**(d) Taxation**

The Club is recognised as being a sporting body and as such is not liable for income tax under CW46 of the Income Tax Act 2007. The Club has a tax exemption certificate from Inland Revenue.

**(e) Principles of Consolidation**

(i) These financial statements are for the group which comprise the Club, its wholly owned subsidiary the New Zealand Kennel Club Gazette Limited and the Museum Trust. The New Zealand Kennel Club Gazette Limited as a company does not trade and all activities associated with the Gazette are treated as a business unit of the Club. The Museum Trust has a term deposit as shown on Note 4, the interest of which is immaterial to the results of the group. As the subsidiaries are either non-trading or are immaterial to the group, the results of the parent have not been shown separately. The balance date of both subsidiaries is 31 March.

(ii) The Statement of Financial Performance on page 4 eliminates all intra group transactions.

**(f) Receivables**

Debtors are stated at estimated realisable value.

**(g) Income Recognition**

Subscriptions and memberships are accounted for on a cash basis with no adjustments for accounts received in advance or arrears. Other income including Affiliation Fees are accounted for on an accruals basis. Those Affiliation Fees received that are related to the next financial year are recorded as receipts in advance. Revenue from gate sales and fund raising activities is recognised on a cash basis, as their receipt cannot be anticipated.

**(h) Donations**

Donations and other gratuities are recognised as revenue at the point when receipt is formally and officially acknowledged by the Club.

**(i) Differential Reporting**

The Club qualifies for differential reporting as it is not publicly accountable or large. The financial statements have been prepared taking advantage of all available differential reporting exemptions.

**(j) Changes in Accounting Policies**

There were no changes in accounting policies.

**(k) Operating Leases**

Leases that do not transfer substantially all the risks and rewards incidental to ownership of an asset the entity are classified as operating leases. Lease payments under an operating lease are recognised as an expense on a straight line basis over the term of the lease in the statement of financial performance.

## FAQ...

### **Why was National Dog Show Income \$23k below budget?**

The initial budget for door sales was revised during the year from \$50k to \$30k as being a more realistic target, and this is reflected in the actual result. Door sales is the most difficult of income items to budget for.

The impact on the bottom line of the revised door sales was that the National Dog Show showed a small loss of \$10,351 which, when weighed up against the profile attained for the event and NZKC, was money well spent.

The difference in the reported loss of \$12,210 and the \$10,351 alluded to here is a positive adjustment made in relation to a Gaming Trust application.

### **Why is Auckland Property Income up \$20k on budget last year?**

The increase on budget relates to a one off receipt in Auckland relating to a prior year event, this being the income from Huntly benefit shows.

### **Auckland Property Maintenance Costs are very high. What contributed to the overspend to budget of \$9k**

Auckland carried out some much needed maintenance, necessary if the premises are to remain in top condition.

### **Other Expenditure is \$416k. What kind of expenses are included?**

These include operating costs that do not fall into the categories that appear in the supplementary schedules

- **Administration/Head Office (NZKC)** – \$185K – incl. Legal Costs, Advertising, Consultants, IT Expenses, Conference Expenses, Catering Expenses, General Expenditure, Travel, Various misc. costs.
- **National Dog Show - \$60K** - The bulk of the National dog show expenses will be Travel, Judges Expenses, Accommodation, Trophies and Prizes, Advertising and Promotions etc.
- **Agility** – The bulk of their expenditure is uncategorised and includes levies paid to NZKC, equipment and equipment grants

### **Salaries, Wages & Other Staff Costs are \$31k over budget.**

Kiwisaver was not budgeted for the current year accounting for \$14k of the variance, with the balance being attributed to the first pay in April 2014, (\$13k), which should have been included in the 2013-14 year, and additional hours worked.

The increase in the 2015-16 budget takes into account the employment of a Canine Health Officer.

**Does the budget include any additional potential sponsorship revenue?**

No, the budget assumes that we will receive a similar level of cash sponsorship.

**Executive Council & Sub-Committee expenses are up \$23K against last year. Why is that?**

The budget for 2014/5 took into account the sharing travel costs for EC delegates to the Executive Committee rather than entirely to events (predominantly ACOD, NDOA, NDAC & NDS). This was noted in the Q&A last year, and the costs now more closely reflect costs incurred by EC members even though they may be attending events.

**Executive Council expenditure includes sub-committee expenses – what makes up the sub committees?**

Apart from the ones that have their own cost centres, they are Disputes, CGC, Canine Health, Accredited Breeders, Judicial Review and Strategic Review.

**What is covered by the Inter Unit transactions?**

Principally rent between Wellington and National Office, together with interest on internal loans to NZKC and Auckland.

**The National Dog Show shows a \$23 down against budget. Why is that?**

As noted above this is entirely due to income being less than budgeted. Actual expenses were in line with budget.

**How much Capital Expenditure has there been?**

Capital expenditure for the 12 months was \$91k with over half of this occurring in Auckland. Replacement of the lighting system, with ongoing savings in electricity costs, and the installation of their own water storage system, were the main items. The only other item of note were new roller doors in Wellington.

**Why is the Depreciation cost so high?**

Depreciation is related to the cost of the assets of which there is in excess of \$4m, the cost of which is spread over the life of the assets. The depreciation rate will vary depending on the life of the asset. Buildings for example have a deemed life of forty years, whilst computer equipment is a lot less at four years. Accounting depreciation is a requirement of accounting standards.
